## **Emergency Covid-19 Cross-border informative chart - SLOVENIA**

**June 2nd**

### **MOBILITY OF PRIVATE PERSONS**

**The Slovenian government canceled the epidemic on May 14th as the spread of the virus slowed down. However, the risk of spreading still exists, so physical distance, hand hygiene and coughing must be strictly observed, and covid-19 patients must be isolated. In enclosed public spaces, it is no longer mandatory to wear a mask or a scarf.**

#### **General rules of behaviour:**

- The national authorities say that all activities with "minimum contact with consumers in accordance with the adopted instructions of the National Institute of Public Health (hereinafter: NIJZ) are allowed",
- obligation to wear masks or other improvised nose and mouth coverage indoors (at stores, gas stations, banks,) and to keep appropriate distance in all places (recommended 1,5-2 meters by national authorities) have generally **been revoked** but are still recommended,
- up until the 30th of April, citizens were confined to their own municipality (Slovenia has many very small municipalities, so this measure meant many were confined to a couple of square kilometers), though there were certain exceptions. This measure has now been redacted,
- outdoors leisure activities, especially on private property (jogging, cycling, tennis, badminton, golf,..) are permitted since 30th of April,
- a new Decree stipulates that sports training is allowed to all athletes. This can be carried out outside or in sports facilities and areas for outdoor sports. The implementation of sports competitions is permitted up to and including the state level and in sports branches that have

a registered official competition system in accordance with the said law,

### **Entry in Slovenia (since 26th of March)**

Incoming travellers from a European Union or Schengen Area member state may enter Slovenia without restrictions and quarantine if they are Slovenian citizens, or foreigners with permanent or temporary residence in Slovenia, or persons with permanent or temporary residence in Croatia and Hungary (Croatia and Hungary are currently on the list of countries whose residents may enter Slovenia without restrictions), or listed among the exceptions in Article 10 of the newest ordinance.

Incoming travellers from third countries may enter Slovenia without restrictions and quarantine (regardless of their citizenship) if they have permanent or temporary residence in Slovenia, or are listed among the exceptions listed in Article 12 of the ordinance.

At the border, the police will provide these travellers with Instructions of the National Institute of Public Health on the implementation of measures to prevent the spread of COVID-19. Instructions are available also in other languages: Slovenian, Italian, Hungarian, German and Croatian.

Entry into Slovenia is not allowed for foreign citizens without permanent or temporary residence in Slovenia who on crossing the border tell the authorities that they are SARS-CoV-2 (COVID-19) positive or have typical signs of infection with this virus (high fever, cough, shortness of breath).

Due to the Covid-19 epidemic, Slovenian citizens are advised not to travel. There are however similar rules to exiting as there are to entering; it mostly depends on the neighboring country's law, therefore the rules they imposed. Most of Slovenia's neighboring countries have similar rules to ours, which are described above.

### **Passing Through Slovenia**

- transit of workers is possible in one day. It is recommended that they carry with them a certificate from the employer confirming they are employees of the company and that they have the task of providing the service, which is urgent.

### **Public transport**

- public transport is now allowed, but the passenger number is limited, which also limits the daily capacity of the public transport system. Passengers have to keep the safe distance of at least 1,5 m and wear masks or other nose and mouth protection.

**Crossborder workers/students** – generally allowed, see above under “entry into Slovenia”.

**Taxis** are allowed for urgent transport, but number of passengers is limited.

### **MOBILITY OF GOODS**

**Transport (airports, ports, inland terminals)** - for the purpose of containing the spread of coronavirus SARS-CoV-2, the Government of the Republic of Slovenia has banned passenger air traffic in Slovenia. The ban has just been lifted, but the system has not yet started functioning at full capacity. Airports in Slovenia re-opened for passenger flights on 11 May.

**Transport by road**- allowed.

**Transport by rail-** allowed. Passenger train connections between Slovenia and Austria remain suspended.

**Transport by sea-** allowed.

**In-home delivery-** delivery personnel is not allowed to enter private homes, yet delivery itself is allowed. Special preventive measures of course have to be taken.

## **BORDER ACTIVITIES**

**Borders opening/controls-** our border control passages are now called “security crossings”. Some have been closed or have a more limited function. Some of our neighbouring countries have also closed some of their border crossings.

**Custom activities-** because of the EU free market rules, radical changes to custom activities are not allowed.

## **ECONOMIC ACTIVITIES**

**Food shops-** open, yet have a limited operating time, especially they are limited by number of customers allowed in store at once, with other safety measures, and with special hours being provided for the elderly shoppers or otherwise immunocompromised.

**Pharma & Medical shops-** open, yet face similar restrictions as described above in the “food shops” segment.

**Gas stations, banks, post offices-** open, yet post offices have just reopened according to the pre-covid schedule a couple of days ago.

Most B2C activities are now allowed.

**Repair – maintenance-** open for urgent intervention or sale of spare parts needed for vehicles and domestic appliances. Only urgent works are allowed in private homes, which are inhabited.

**Retail sale** (not food related)- generally allowed, except for the exceptions listed above.

**Wholesale** - allowed

**Restaurants/Pubs/Coffee shops etc.-** at the beginning of epidemic, only delivery was allowed and then also take-away services, and since 4th of May, open space terraces are allowed.

**Personal care** (beauty salons, hairstylists, massages): opened since 4th of May, with the use of all the necessary personal protective equipment (PPE) for workers and clients.

**Fish/agriculture** - allowed

**Construction and building activities** – generally allowed on uninhabited objects, workers need to follow precautionary rules.

**Other industries (wood, shipbuilding)** – allowed with safety precautions.

## **Education**

Schools/ Universities – with effect from 18 May 2020:

- \* all kindergartens in the country are open
- \* primary schools for students from 1st to 3rd grade are open
- \* primary schools with a customized program are open
- \* secondary schools for final year students of the secondary school and individuals who will take the “matura” or final exam in the 2019/2020 school year, and for students from the 1st to the 3rd year for whom the school organizes additional teaching aids or the acquisition of practical knowledge and skills are open

From 18 May onwards, the following may also have reopened:

- \* music schools,
- \* institutions for the upbringing and education of children and adolescents with special needs, and
- \* vocational colleges.
- \* universities and higher education institutions,
- \* student dormitories for students returning to school, for those students who are prevented from returning to their place of residence due to the current security situation, unaccompanied minors in student dormitories with the status of an applicant for international protection or recognized international protection and for students living in dormitories.

From 25 May 2020, classes were reopened for:

- \* 9th grade students of primary school and primary school with a customized program,
- \* those students from 4th to 8th grade of primary school and primary school with an adapted program with learning difficulties who need adapted forms and methods of work to achieve minimum standards of knowledge,
- \* pupils and students of special education programs in primary school and primary school with an adapted program.

For all other pupils and students who were not specifically listed, distance education continues.

## **Culture**

**Cultural activities (theaters, museums, concerts, cinema)** - The newest decree allows gatherings of up to 50 people, if it is possible to ensure minimal contact between people in

accordance with the adopted instructions of the National Institute of Public Health (NIJZ). When organizing gatherings of people (eg. public events), the organizer must ensure the measures of the NIJZ and also make sure that people respect these measures.

**Public events (fairs, tradeshows, festivals)-** see above. Nightclubs are closed.

### **Tourism**

**Mobility for tourism** – generally allowed.

**Hotel and other accomodation structures** – now generally open. Government also gave citizens a special voucher meant to kickstart tourist accomodation activities.

**Other tourist activities (marinas, mountain huts & alpine farms)** – open.

**Campings-** open space activities are allowed.

**Seaparks, adventure parks** – open space activities are allowed.
